Schools may be closed due to the coronavirus, but we know that has not stopped communities from finding new ways to feed kids. And No Kid Hungry has been helping.

Our team of experts and network of consultants have provided technical assistance and support. We have:

- Helped schools and community organizations navigate and understand USDA waivers.
- Offered ideas around meal distribution, staff safety, staffing, planning for emergencies, communication, partnerships & more.
- Identified challenges and developed solutions.
- Shared best practices and lessons learned from school districts and community organizations across the state and country.

Where Our Grants Are Helping:

- Spanning the entire state, Feeding Florida is using our funds to support their 12 member food banks who work with more than 2,300 community-based partner agencies to provide food directly to families.
- The Tampa Bay Network to End Hunger is delivering weekly meal packs and groceries to kids who can't reach community feeding sites. They expect to deliver 5,000 meals each week.
- Duval County Public Schools is using our grant to feed kids healthy lunches and snacks while classrooms are closed.
- Hamilton County School District is delivering around 1,700 meals a day to kids in need who aren't able to reach meal pick-up sites.
- The Homestead Soup Kitchen is using funds to ensure that kids in their area can count on three healthy, hot meals a day while school is closed.
- Redlands Christian Migrant Association launched meal pick-up sites, where vulnerable families can receive bags of food. They also deliver to those who can't make it to the site.
- Monroe County School District is using funds to support a drive-thru meals site and delivering food to additional community centers.
- Second Harvest of the Big Bend food bank is distributing food to kids in need across 11 counties in northwest Florida.
- United Farmers Alliance in Loxahatchee is using grant funds to create a farm to family pipeline of local foods that will support farmers and hungry children alike.
- Central Florida nonprofit 4Roots is supplementing existing meals sites and building a network of restaurants and caterers to help fight hunger.
- In Palm Beach Gardens, Little Smiles of Florida is delivering food to children living in a local shelter or facing other crises.
- Meals of Hope in Naples is getting fresh produce, frozen meats and vegetables, dairy and other staples to distribute through eight mobile food pantries across their region.
- Central Florida's Orange County Public Schools are operating 55 feeding sites throughout the county to provide an estimated 38,500 meals each day for hungry kids.

Where Our Grants Are Helping (pg. 2):

- Palm Beach County School District's Food Service Department is using grant funds to operate 35 emergency feeding sites that expect to serve 40,000 meals a day.
- Salvation Army of Naples have expanded their work to feed an estimated 800 hungry kids that are losing meals due to school closures.
- The School Board of Miami-Dade County is using funds to purchase and distribute fresh produce to kids and their families as part of their grab-n-go meal program.
- The Thomas Promise Foundation is providing backpack meals for kids in need at 28 schools across Pasco County.
- Pace Center for Girls is using our grant to purchase food and deliver it to the homes of at-risk girls and their families across the state.
- Fort Pierce Seventh Day Adventist Church have mobilized their staff and volunteers to deliver meals to those without transportation to reach meal sites. They expect to serve 19,200 meals.
- The Florida State Alliance of YMCAs Foundation is using their No Kid Hungry grant to help local YMCAs in 37 counties provide meals to kids.
- The School District of Osceola County is using funds to get food, safety equipment and supplies to help their staff feed more kids.
- Santa Rosa County Schools is spending our grant on ice chests and food storage bags to safely deliver meals by bus to kids across their rural county.
- Leon County Schools is ensuring the safety of their Nutrition and Food Services staff by using our grant to purchase protective equipment and support their operations.
- The Florida Alliance of Boys & Girls Clubs is using our grant to serve meals to kids at 12 of their Clubs in different areas of the state.
- The School District of Manatee County is buying protective equipment for their staff and meal service supplies to safely package and serve meals.
- Clay County District Schools is using funds to support their staff as they serve breakfast and lunch at 17 sites across their county.
- The Early Learning Coalition of Palm Beach County is using their network to provide essential food to families with infants and young kids.

Where Our Grants Are Helping (pg. 3):

- The Salvation Army, Sanford is purchasing food and meal service supplies with our grant and delivering meals to vulnerable populations, including the homeless and domestic violence survivors.
- Lafayette District Schools will continue providing meals through the summer to kids across their county. They are using our funds to purchase food and food delivery supplies and to support their staff.
- Coalition for the Homeless of Central Florida has expanded their community feeding program in addition to their normal feeding program for families in their residential facilities. Our grant was used to purchase equipment and support their staff, so they may continue to serve over 1,000 meals a day.
- Farm Share is spending our grant on supporting their farm to community food distribution program that supports both farmers and communities with high rates of food insecurity. Our funds will help them serve 800,000 meals per day across the entire state.
- Madison County School Board is ensuring the safety of their staff by purchasing PPE and sanitizing products. They are also purchasing food service supplies so they can safely distribute meals to kids.
- Florida Recreation and Park Association will be distributing our grant funds to park and recreation agencies across the state who have the greatest need for support to feed kids.
- Alachua County School District is spending our grant to purchase food and meal service supplies to safely package meals for distribution. They plan to serve 750,000 meals over the summer.
- Polk County Public Schools is using our grant to support their staff as they serve 20,000 meals a day.
- In North Central Florida, Hedges and Highways Outreach Ministries is spending funds to purchase food service equipment and supplies. They are also purchasing additional food to distribute throughout the five rural counties where they operate.
- We Care Food Pantry is distributing food to 30 food pantries throughout four rural counties in West Central Florida. They are using our grant to purchase food service supplies and support their staff and food delivery process.
- The School Board of Broward County is using a No Kid Hungry grant to provide an estimated 50,000 meals a day to kids and families affected by the pandemic.
